### Rules

1. 3 players per team on the court at once.
2. Points are scored in increments of 1 and 2 (2 point baskets are worth 1 and 3 point baskets are worth 2).
3. If possession changes, the team with the newly acquired possession must take the ball past the 3 point line.
4. Referees will call all fouls.
5. Games will last 8 minutes. It will be a running clock.
6. In the event of a tie game when time expires, the team will play sudden death- next point wins. Rock, paper, scissors will decide who receives ball.
7. All rules applicable to 3v3 basketball apply.
8. In the event of a jump ball, the team on defense will receive the ball.
9. Who receives the ball at the beginning of the game will be determined by a coin flip.
10. Substitutions may be made at any dead ball, however they are not required.
11. Disrespect to score keepers or staff will result in a warning . A second offense will result in disqualification.
12. Bad sportsmanship will not be tolerated, from players and spectators, and may lead to a disqualification.
13. The championship will be played in a "win by 2" format, meaning whichever team wins must beat the other team by at least 2.
14. If a team fails to show up prior to the stated start time, the team will forfeit the game.
15. Team names must be school appropriate.
